In June 2023 I was working on Skynet Killfeed with Kamikaze0420, after a dispute over workload I gave him the choice to help with the code more or I leave and make my own bot, he told me to leave so I deleted the application, deleted the files and left.

Since June 2023 they have stalked and harassed me on discord, on discord alts, on reddit, on facebook, on twitter, they've saved pictures of my kids and messaged them to other people across multiple discords, they even messaged pictures of my 4yr old and 8yr old to my admins on facebook, they have several websites live slandering me, they've admitted to ddossing me, they've slandered my bot (Legion Killfeed) for a year, they've significantly negatively affected my bot and my business with their constant harassment and stalking.

Most recently, they have been telling me to kill myself on discord, they've told heaps of people I "rape my kids" and I am borderline ready to kill myself. No matter how many times their lies, suicide and rape lies get reported, nothing is done about it. Why isn't discord taking this seriously? Proof - <https://postimg.cc/gallery/km17ymLs>

Even the code running on "Skynet 2.0" (Bot's Discord ID: 1122392648553082920) I have proof that he uploaded my code to ChatGPT and my log file from my Nitrado servers to rip off my code for his "api".

He kept slandering me every chance he could. He lied to his entire discord saying he rewrote the whole bot overnight he claimed it was written in js now but it still threw python errors.

He lied about who did what work and here is every single time I tested, every single sync and every single action done to the killfeed, it shows who actually did the work. Proof - <https://postimg.cc/gallery/Lpb0Yt9Z>
- File Saved is every single time I tested something
- Syncing is applying changes to the killfeed
- Mass search and replaces were changing assigned stuff from being in every file to be in one file to be called upon

His contributions were 14.8% added lines of code contributed and 10.18% deleted lines contributed and they were well-and-truly written over with my 65.68% added lines and 63.42% deleted lines.*

He says I kept syncing errors, whenever I did sync an error, I always fixed it almost immediately, it's impossible to not get errors and when your test environment isn't identical to your running environment there will be issues.

The discord for Jeaber's Killfeed Support (Discord ID: 667103424147488773) has no moderation as the owner is in prison (for kidnapping), they use this discord to slander me in front of all the people who are potential customers in the future.

He's threatened to release my code to further tarnish my business which is registered under ABN: 28387377607 (Anthony Gordon Brodie), it goes by Legion Killfeed and is a discord bot that downloads logs from Nitrado.net and parses the files into a readable format tracking stats, leaderboards, servers and more.

His entire bot "Skynet 2.0" is ripped off from my code and he has deluded himself into believing I did wrong by him.

I can even show that he has uploaded my files to chat gpt to steal my work.
