

**Formal Criminal Complaint to Canadian Authorities: Brett Jones (aka "MrTechN9ne")**

**Re: Criminal Defamation, Fraud, Harassment, and Conspiracy by Canadian Resident Brett Jones**

**I. Executive Summary: Transnational Criminal Enterprise**

Brett Jones (alias "**MrTechN9ne**"), a Canadian resident, has orchestrated a **coordinated criminal campaign** involving:

1. **Defamatory Libel** (§301 CCC): Public false accusations of pedophilia.
  - a. **Falsely accused Anthony Brodie of pedophilia across platforms (Discord/Facebook).**
2. **Fraud & Identity Theft** (§380/402.2 CCC): Stolen identities for financial scams.
  - a. **Orchestrated fraudulent PayPal disputes using fake identities ("Randy Layhe").**
3. **Criminal Harassment** (§264 CCC): Sustained threats and mob incitement.
  - a. **Deployed proxies (NoisyBoii) to fabricate service complaints and justify fraudulent refunds.**
4. **Conspiracy** (§465 CCC): Proxy sabotage and cross-platform attacks.
  - a. **Conspired to sabotage Legion Killfeed through coordinated harassment.**
5. **Mischief to Data** (§430(5.1) CCC): Intentional business sabotage.

**Jones' actions violate Canadian Criminal Code §§ 298-301 (Defamatory Libel), 380 (Fraud), 430(5.1) (Mischief to Data), and 465 (Conspiracy).**

**Jones' actions violate Canadian sovereignty by using domestic infrastructure (Discord/Facebook servers) to commit crimes impacting a foreign business.**

### Modus Operandi:

- Uses gaming communities (DayZ) to recruit attackers.
- Deploys proxies to fabricate "evidence."
- Exploits financial systems (PayPal) for theft.
- Evades detection via fake accounts and international borders.

## II. Complete Chronology of Criminal Acts

### Phase 1: Defamation Campaign (July 2025)

### Phase 3: Coordinated Business Sabotage

Tactic	Platform	Evidence

Server Corruption	Discord	Unauthorized configuration changes pre-ban Server logs (Brett Jones.pdf, Pg 4)
Mob Incitement	Multiple	Recruited others to mass-report services

### III. Legal Violations Under Canadian Law

#### A. Defamatory Libel (§298-301 CCC)

- **§300:** Published false pedophilia accusations to incite hatred.
- **Aggravating Factors:**
  - Malicious intent (retaliation for termination).
  - Dissemination across multiple platforms.
  - Refusal to retract despite evidence.
- **Maximum Penalty:** 5 years imprisonment.

#### B. Fraud & Identity Theft (§380/402.2 CCC)

- **§380(1)(a):** Caused financial loss via:
  - Fraudulent PayPal disputes.
  - Proxy-assisted refund scams.
- **§402.2:** Impersonation of "Randy Layhe" (fictional identity).

#### C. Criminal Harassment (§264 CCC)

- **§264(2)(b):** Sustained communications causing fear for safety, including:
  - Threats to destroy business ("*Legion will fall*").
  - Recruitment of harassers.

#### D. Conspiracy (§465 CCC)

- Collaborated with Danny Hayes (UK) and proxies (Noisy Boii) to:
  - File fraudulent financial claims.
  - Bombard platforms with fake reviews.

#### E. Mischief to Data (§430(5.1) CCC)

- Intentionally corrupted server configurations to disrupt services.

#### **IV. Jurisdictional Nexus to Canada**

1. **Perpetrator Residency:** Brett Jones operates from **Toronto, ON** (confirmed):
  - a. **PayPal verification data** (requires Canadian address).
  - b. **Discord/Facebook metadata** (law enforcement subpoena able).
  - c. Self-identification in voice chats (corroborated by witnesses).
2. **Harm in Canada:**
  - a. Defamatory content accessed by Canadian users.
  - b. Legion Killfeed serves 200+ Canadian clients; reputation damaged locally.
  - c. Fraudulent disputes processed via PayPal Canada.

#### **V. Evidence Bundle**

1. **Defamation Evidence:**
  - a. Discord logs (MrTech2.webp).
  - b. Facebook posts (Brett Jones.pdf).
  - c. Termination notice (MrTechS.jpg).
2. **Fraud Evidence:**
  - a. PayPal disputes (paypalMrTech.png).
  - b. NoisyBoii chat logs (noisyboii.png, noisyboii6.png).
  - c. Service logs proving 604 commands (Brett Jones.pdf).
3. **Conspiracy Evidence:**
  - a. Trustpilot fake reviews (Trustpilot Complaint).
  - b. Server corruption logs (Brett Jones.pdf, Pg 4).

#### **VI. Requested Actions**

1. **Lay Criminal Charges** against Brett Jones for:

- a. Defamatory Libel (§301).
  - b. Fraud (§380).
  - c. Identity Theft (§402.2).
  - d. Criminal Harassment (§264).
  - e. Conspiracy (§465).
  - f. Mischief to Data (§430(5.1)).
2. **Issue Production Orders** to:
    - a. Discord/Facebook: For Jones' IP logs, message history.
    - b. PayPal: For "Randy Layhe" account verification data.
  3. **Execute Search Warrants** for Jones' devices (computers/phones).
  4. **Coordinate Internationally** with UK/Australian authorities for parallel investigations.

## VII. Legal Grounds for Urgency

- **Continuing Harm:** Jones remains active on Facebook commenting about Legion and Anthony.
- **Public Safety Risk:** False pedophilia allegations could incite vigilante violence.
- **International Comity:** Parallel investigations in UK/Australia require Canadian action per *Mutual Legal Assistance Treaty*.
