Outcome of the appeal

Thank you for reaching out regarding the disputed review.

The Content Integrity team evaluates flagged reviews strictly based on the specific Reporting Reason selected at the time of submission. In this case, the review by Ray Smith was reported under the "Advertising or promotional" category. 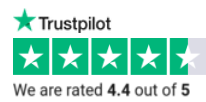
